- Vendors who have downloaded tender document from internet are required to submit tender document fee in the form of DD in favour of 'Director, IITM, Pune' along with their technical bids.
- 2. Clarification regarding Sr. No. 4 of page no. 4 i.e. Prime Contact of at least one Single project of not less than Rs. 50 Lakhs. As we asked about annual turnover of Rs. 50 Lakhs during any two years of past 5 years.

'For the above clarification IITM agreed to accept two projects of Rs. 25 Lakhs each.'

- 3. Other technical enquiries were discussed and clarified by Dr. Kandaswamy (AV consultant) over skype and there was no change in BOQ. However for further clarifications all the bidders were advice to meet the AV consultant in person on 07.02.12 at the same venue at 1100 hrs.
- 4. Bidders raised enquiry about evaluation of equivalent product, committee has clarified that all the bidders are required to quote the make and model numbers matching the specifications clearly in their technical bid and TEC will evaluate the same.
- 5. Bidders have asked about bids with multiple options:
