At the outset the committee welcomed all the Vendors/companies participating in the prebid meeting and discussed about the basis of tendered requirement present architecture of HPC..etc.

The following are the queries clarified and amendments accepted on the technical issues:

- a. Specifications SI No. 10 'Performance requirements' 5 GB/Sec simultaneous write & read throughput is amended to '5 GB/Sec write throughput'.
- b. Specification SI No.2 'Eligibility' is **modified to** 'Storage OEM vendor must have supplied minimum 500TB of storage with the proposed same model or better to at least 1 site in top500 in year 2011. Vendor must provide reference of these sites with storage architecture and contact details of the reference'.
- c. Specification SI No.6 'Controllers' sub point 'at least 12GB ECC protected battery backed cache' is amended to 'Minimum 12 GB ECC protected battery backed cache at any given time'.
- d. Additional point included is 'The present compute network and the storage IO nodes are connected on DDR. It is expected that the vendor should interface QDR based Storage solution with the present DDR Infrastructure. And the proposed solution should seamlessly interoperate, exchange data with the existing storage solution at IITM'.

The following are the queries clarified and amendments accepted on other terms and conditions.

- a. Vendors should quote their prices as per the format enclosed herewith to evaluate the L1 bidder.
- b. Point 22 in terms and conditions is deleted.
- c. Delivery Schedule will be 8 weeks for delivery and 2 weeks for installations.

d. Penalty clauses will be as follows:

If the supplier fails to Supply and Install the system as per specifications mentioned in the order within the due date, the Supplier is liable to pay liquidated damages of one percent value of the Purchase Order awarded, per every week delay subject to a maximum of 10% for every week beyond the due date and such money will be deducted from any money due or which may become due to the supplier.

- e. Point No. 49 of terms and conditions is modified to 'The Vendor should give support valid for three years with 4 hours response time and Next business day resolution including configuration issues'.
- f. Point No. 50 of terms and conditions is modified to 'The vendor needs to have a full fledged support office to ensure the warranty and extended warranty support'.
- g. Amendments requested on Point No. 48 of terms and conditions is not accepted by the committee.
- h. Point No. 20 of terms and conditions is modified to 'Vendor should arrange 3 days on site systems administration and user awareness training free of charge and 2 days refresh training after every six months during the warranty period and extensions if any'.
