- 3. In the list of approved makes for 3500 DLP Projector, 'Hitachi' make is included and accepted by the committee.
- In the list of approved makes for 10000 ANSI Full HD (Main Projector), 'Barco' make is included and accepted by the committee.
- 5. In the list of approved makes for LED Displays, 'Panasonic' make is included and 'JVC' make is deleted and accepted by the committee.
- 6. In Technical specification point No. 25 is "SITC of Flame-guard-FRLS PVC speaker cable for sub-woofers: 4 core, 4 Sq. mm, 56 strands, each strand of 0.3 mm thickness.

10.Other queries

- a. Querry raised on input details (Transmitters and Receivers) are confirmed to be as per the Video distribution diagram, and relevent items are included in the BOQ. No addition is envisaged.
- b. In the case of HDMI cables, the requirement of repeaters was raised for lengths beyond 5 m. The same will be, as per the vendors selection of equipment, and if repeaters are required, then they are deemed to be included in the quoted rates of the respective items.
- c. The Video conferencing system specified in the BOQ item No.71, includes Data Solution Software for PC Connectivity and also includes multi-point connectivity software for connecting 4 (1+3) centres on IP/ISDN.

d. The quantities for BOR item NOS 47, 49 and 50 She Numbers are 10, 10 and 01 respectively. Clarification on Commercial and Other terms and conditions of the tender

- EMD will be acceptable from Nationalized bank scheduled bank in the form of BG/DD. And BG should be valid for 180 days, even if mentioned otherwise elsewhere
- Quote should preferably be in INR (Indian Rupees)
- 3. EMD will be returned within 90 days or on issue of LOI or whichever is earlier.
- 4. Manufacturers Authorization Form/ Letter is compulsory.
- 5. Upon Bidders requests the Sec 5.3 Pre- Qualification is revised on below issues.
 - 5.3 (5) Bidder is preferred to be an ISO 9001:2000/2008 Certificate.
 - 5.3 (6) Bidder should have completed Installation of minimum 3 works with minimum 3 crores nationally or internationally and should be in the AV field for the last 10 years. (Documentary proof, work orders, completion & satisfaction certificates should be given)
