- 1. नियत तारीख के बाद प्राप्त दर सूची पर विचार नहीं किया जाएगा।
  - Quotation received after the due date will not be considered.
- दर सूची स्पष्ट अक्षरों में भरी जानी चाहिए और अधिलेखन/सुधार, काटछांट आदि हो तो उनको विधिवत अनुप्रमाणित करना चाहिए और आपके पत्रशीर्ष पर ही होना चाहिए।
  - Quotation must be filled in legibly and overwriting/corrections, erasures etc. if any, must be duly attested, and ON YOUR LETTERHEAD ONLY.
- 3. पूछताछ पत्र में दर्शाई गई इकाइयों के अनुसार दरें प्रस्तुत की जानी चाहिए। जब दरें विशेष रूप से उल्लिखित इकाइयों से अलग हों तब इकाइयों के बीच संबंध दर्शाया जाए।

- 22. Company must have at least 3 years of experience in Hosted IVRs as project SAFAR is highly prestigious national project.
- 23. Voice Talents should have at least 3 years of recording experience.

- 24. Company should clearly specify the fixed or recurring cost for each of requirements. Cost must be itemized including requirements gathering, design, development, setup, toll free number rates, PRI rental, annual maintenance cost if any and yearly maintenance as per clause 25 (each year) and support for 5 years.
- 25. Company must include their platform architecture diagram explaining high level Hardware (Servers, Gateways, Firewalls, Routers, and Switches etc.) details like manufacturer, model, CPU, memory, storage etc.
- 26. Company must put high level of time estimates (In months/weeks) for the design, develop, test and deployment of the IVR.
- 27. IITM reserves the rights to audit or visit the company data center physically to verify the submitted platform architecture by giving 24 hour notice for the visit.

  Above service should be completely maintained on sustainable basis for at least a period of 5-years.

# **Specification of "IVRS System for SAFAR-Pune"**

IVR System will be deployed on company's data center. There is no hardware or software installed at IITM Pune premise except a mirror data ftp server. Company will submit the bid as per the following specifications.

- 1. Design and develop a comprehensive system to play the Air Pollution and weather information about specific regions and sub regions of Pune over the phone.
- 2. Design Integration and Transformation layer to pull the air pollution and weather (current and forecast) data from IVRS server of IITM in near real-time.
- 3. Transformation layer must understand and parse GTS weather data format.
- 4. Transformation layer must understand air pollution data in XML format.
- 5. Integration and Transformation layer should be able to map air pollution data to apt human understandable messages as defined by IITM.
- 6. Design a web portal for Manual weather and Air pollution data feed and various data reports like (Manual updates audit logs, historical data reports, daily, weekly and monthly call reports etc) at your server which should be accessible by IITM.
- 7. Design a user friendly IVR system: Caller must be able to get the required information in least inputs.
- 8. IVR application development should be based on open standard technology like (e.g. VXML, CCXML). Proprietary code must NOT be used.
- 9. IVR application should allow caller to choose the preferred language and need to be done in 3 languages (Hindi, English and Marathi).
- 10. IVR application must be designed to handle the Alerts and Warning messages in Real Time.
- 11. System should allow recording of important warning message(s) in real time over the web portal in case of pre-recorded message(s) are not available.
- 12. The complete system must be deployed in a secure data center or hosted platform. It should be physically locked and should be under close circuit cameras surveillance.
- 13. IVR application must be deployed on dedicated high end Rack/Blade servers.
- 14. Data center must be fault tolerant and it must not have a single point of failure of any kind.
- 15. Data center must have failover on power, firewalls, routers, switches, gateways, servers, storage, internet, telephony etc.
- 16. IVR should be able to use Text To Speech (TTS) in case recording is not available.
- 17. IVR platform should be capable of Voice Recognition for future use.
- 18. Company should assign a Toll Free number for people to call the IVR. The securing toll free number for IITM would be under the scope of the vendor for which necessary letter may be issued, if required by the service provider.
- 19. Initially toll free number should be able to take up to 30 simultaneous calls (one PRI).
- 20. IVR platform must be scalable to support hundreds of simultaneous calls.
- 21. IVR platform must be capable of sending Air pollution and weather information over SMS also.
- 22. IVR prompts should be recorded in all common regional languages.
- 23. SLA should be at least 99.8% uptime for IVR and web portal.

24. The Mirror Server for ftp weather data to be located at IITM should be provided by the vendor as per the latest specifications

25. The above mirror server at IITM location will be used by the company IVRS server infrastructure to pull the air pollution and weather data to play it to callers.

#### PART-B: Specification of "IVRS System for SAFAR-Delhi"

- 1. Design and develop a comprehensive system to play the Air Pollution and weather information about specific regions and sub regions of Delhi over the phone.
- 2. Company should assign a separate Toll free number for people to call the Delhi IVR.
- 3. IVR application should allow caller to choose the preferred language and need to be done in 3 languages (Hindi, English and Punjabi).
- 4. Vendor should deploy separate set of server instances for Delhi IVRS. There should not any sharing of servers or PRI for Delhi and Pune IVRS. This is to avoid both IVRS down caused by single set of server or PRI failures.
- 5. Vendor can design and code the IVR and web portal which can be used if possible for both IVR systems.
- 6. Rest of the specifications for the Delhi IVR is SAME (Identical) except there is no mirror server required for Delhi.

**Note :** (i) **Make, Model name & Warranty Period** of the equipment may be mentioned clearly failing which quotation will not be considered.
