

Sub: Minutes of Prebid meeting- ILL services

A Prebid meeting was ^{held} ~~scheduled~~ at HPC building conference hall on 27 Sept 13 at 1100 hrs for tender Enquiry No. C-050.35-II dated 29 Mar 12 "Procurement Internet Lease Services". The following members were present

Seventeen representatives from seven different vendors/companies participated in the same as per the Attendance List.

At the outset the committee welcomed all the Vendors/companies participating in the prebid meeting and discussed about the requirements.

The following are the queries clarified and amendments accepted as per the vendors requests **on technical issues**:

- a. **Tender Annexure-I (Eligibility criteria)** SI No. 3 is modified to *"The ISP should have Extensive Peering relationship with large number of Global Tier-1 and regional Tier-1 ISPs across globe. The details should be mentioned in the technical bid for evaluation by the TEC of Institute."*
- b. In SI No.4 "...multiple Internet gateways..." is modified to *"...redundant Internet gateways..."*.
- c. SI No. 5 regarding "...submarine cable.." is removed.
- d. **In Technical requirements** SI No.1 The quote for "...75 Mbps, 100 Mbps.." is removed.
- e. SI No. 2 is modified to *"The Internet bandwidth services should be with a built-in DDOS protection. The ISP should cater for minimum of 5 times the base ordered bandwidth for mitigation purpose. The vendor should **submit two commercial bid formats i,e 1. With built-in DDoS Protection (clean bandwidth) and 2. Without built-in DDoS Protection.** As per the TEC recommendations only one of the commercial bid will be opened which will be informed to the vendors before opening of commercial bids."*
- f. SI No.7 "...uptime of minimum 99.9%.." is modified to *"...uptime of minimum 99.5%.."*.

The following are the queries clarified and amendments accepted **on commercial and other terms and conditions.**

- a. In SI No 45 on **Penalty for delay in commissioning** is clarified as the Penalty will applied on the "**One time Installation charges of the commercial bid**" only.
- b. The Installation and commissioning period is increased from **two weeks to Four weeks** from the date of issue of LOI.
- c. The revised commercial bid format and evaluation criteria is as follows: (**Vendors are required to submit two commercial bids as per technical issues clause e above by clearly mentioning on the covers for option 1 (With Built-in DDoS) & option 2).**
