## Terms & Conditions

- Tenders/quotations, addressed to the Director, Indian Institute of Tropical Meteorology, Pashan, Pune-411008 must be submitted in sealed cover super scribing "Quotation for Comprehensive Maintenance"
   Contract for Lerner Hypermax ZXi 40-Telepresense Room", Due date 22nd October 2014
- 2. The Tenderers are requested to give detailed sealed tender in their own forms in two Bids i.e.
  - Part I Technical Bid.
  - Part -II Commercial Bid.

Both the sealed bids should be sent in another sealed envelope addressed to the Director, Indian Institute of Tropical Meteorology, Dr. Homi Bhabha Road, NCL Post, Pashan, Pune -411 008, INDIA so as to reach on or before 22<sup>nd</sup> October 2014.

- You have to be Submit EMD of Rs. 30,000.00 (Rs. Thirty thousand only) in the form of Demand Draft,
   Banker's Cheque or Bank Guarantee from Nationalized Bank in favor of Director, Indian Institute of
   Tropical Meteorology, Pune.
- 4. You have to submitting Rs. 500.00 (Rs. Five hundred only) towards Tender Document Fee in the form of Demand Draft, Banker's Cheque in favor of Director Indian Institute of Tropical Meteorology, Pune.
- 5. You have to submit two separate bids in two separate envelopes and you may keep both the bid envelopes in an envelope for sending to us. One envelope will contain only the TECHNICAL SPECIFICATIONS, EMD and Tender Fee Amount. Another envelope will contain only the financial bid AMC Price etc. and any other information, which has financial implications,. The main envelope, which will contain both the bids, should be super scribed with our tender enquiry No. PWS/141/2014/27 due on 22nd October 2014, "Quotation for Comprehensive Maintenance Contract for Lerner Hypermax ZXi 40-Telepresense Room".
- 6. The technical bids will be opened on the specified due date & the financial bids of only those bidders will be opened whose technical bid is found suitable by us.
- 7. This tender is not transferable.
- 8. Quotation received after the due date will not be considered.
- 9. The quotation must be valid for a period of 90 days from the date of opening.
- 10. Quotation received by fax or email will not be considered.

- 11. EVAMP (Enhanced Value Added Maintenance) is inclusive of free attendance to all service calls & free repair/replacement of all defective parts of all audio equipment and by equivalent or higher specifications and also cover both preventive as well as corrective maintenance.
- 12. The hardware and software problems will be reported to the contractor and will be attended by them based on priority indicated by IITM. On some occasions such complaints may be given directly by the IITM on non-working days/off duty hours or in emergency telephonically.
- 13. CMC includes the supply of relevant support packs and other software also for existing hardware.
- 14. System can be inspected on any working day (Monday to Friday) between 10:00 Hrs to 17:00 Hrs.
- 15. Response Time will be within one day, and same day will be Resolution time.
- 16. Uptime: during the EVAMP period contractor will be responsible to maintain the equipment in good working condition by maintaining 95% uptime on all working days.
- 17. Downtime: the downtime will start from expiry of response / resolution time. If the downtime has exceeded by 2.5% the agreement will get extended by two days for every one day of delay.
- 18. In case the equipment cannot be repaired within the resolution time standby equipment would be provided by the contractor.
- 19. The contract will be valid for one year; Institute can terminate the contract if performance is not satisfactory.
- 20. Maintenance service should be available from Monday to Friday from 9:30 to 18:00 hours.
- 21. The contractor would carry out preventive maintenance once in every 03 months. Failure to do so shall attract penalty as deemed fit.
- 22. The items that are defective and need to be replaced would be first checked by the IITM's Computer/IT Cell before those are declared as defective. The defective equipment/ items will be replaced by the equipment/ spares of the same specification/ make and, in case these are not available, the equipment with higher specification will have to be installed.
- 23. Quarterly review of maintenance done by company manager.
- 24. The contractor shall keep sufficient quantity of spare parts and other required spares available centrally for ready use.
- 25. The engineers will not change the setting of any equipment without seeking the prior permission and information of computer division staff of the institute.

- 26. The contract is comprehensive and covers free replacement of all defective parts,
- 27. The contractor shall not further sublet of the CMC under any circumstances to a third/ sub-contractor for the maintenance.

- 28. The software maintenance shall include loading, reformatting to software, system/network, configuration and installation of software purchased by the IITM of the aforementioned category from time to time.
- 29. The contractor shall have to depute at least one well qualified engineer having a minimum experience of three years in the relevant field. The service engineer has to report at 9:30 hrs. and will work up to 18:00 hrs. On all working days.
- 30. Successful contractor within period of 10 days has to submit an agreement for the value not less than 100/- on a Non-judicial Stamp Paper and Bank Guarantee for 10% of the total cost of CMC. Valid till the end of Contract period towards performance security for smooth performance of the CMC.
- 31. Payment Terms: 1. No Advance Payment 2. Quarterly Payment after completion of each quarter
- 32. The Institute reserves the right to accept or reject any quotation or part thereof without assigning any reason thereof.

## BID SECURITY FORM

- 1. If the Bidder withdraws it's bid during the period of bid validity specified by the Bidder on the Bid Form; or
- 2. If the Bidder, having been notified of the acceptance of it's bid by the Purchaser during the period of bid validity:
  - a) fails or refuses to execute the Contract Form if required; or
  - b) Fails or refuses to furnish the performance security, in accordance with the Instruction to Bidders.

We undertake to pay the Purchaser up to the above amount upon receipt of its first written demand, Without the Purchaser having to substantiate its demand, provided that in its demand the Purchaser will note that the amount claimed by it is due to it owing to the occurrence of one or both of the two conditions, specifying the occurred condition or conditions.

This guarantee shall remain in force up to forty five days after the period of the bid validity, and any demand in respect thereof should reach the Bank not later than the above date.
