The team members of the Expert auditors should be qualified lead assessors and research and publication back ground.

The consulting organizations can also be allowed to bid as a consortium for this project. However in such a situation Expert auditors in individual partner organizations need to have an active role. In such cases evidence towards existence and rationale for consortium needs to be furnished.

#### 13. DOCUMENTARY EVIDENCE TO BE SUBMITTED TO SUPPORT ELIGIBILITY

- a) Contract work orders indicating the details of assignment, client, value of assignment, date and year of award.
- b) Detailed resume of the team leader and team members indicating the details of qualifications and professional experience
- c) Certificate of lead assessor course undergone by the team leader and team member(s) Minimum 5 research projects Published in National and International conferences and / journals Preferably a research guide from a reputed university having exposure to mange research projects and publication, Association with training and social awareness drives recommended. Evidences for social projects and awareness drives in form of published reports, seminar proceedings, and stake holder's feedbacks could be submitted.

#### 14. PROPOSAL SUBMISSION

Interested auditors should submit both technical and financial proposals combined. This outer envelope shall bear the title of the assignment "Engagement of Expert auditors for providing internal auditors training and guidance for obtaining ISO 9001:2008 certification of Government Departments".

# i. TECHNICAL PROPOSAL CONTENT

Technical Proposal should be prepared considering the Terms of Reference, Detailed Approach and Methodology, Activity Schedule & Deliverables. Time period and any other information to highlight the capability of the auditors.

Technical Proposal must include:

- a. Brief description about the auditors
- b. Expert auditors s experience: In addition to over all experience of the auditors, details of specific research/ consultancy projects/studies undertaken may be provided including Assignment / project name, publication reference etc.
- c. Team size
- d. Detailed Resume of the Team leader and team members of the Expert auditors (with copies of certificates to support qualifications) Research qualification, social drives

# ii. FINANCIAL PROPOSAL CONTENT

• Financial proposal (in Indian Rupees) should be in the form of a lump sum amount inclusive of all taxes for the entire *Scope of Services*.

• The lump sum quote should be inclusive of all expenses which the auditors may incur while executing the assignment including Travel Boarding & Lodging as required.

Payments shall be made according to the following schedule:

- 25% After completion of documentation
- 25% After completion of internal audits
- 50% After certification of the Institute

#### **AGREEMENT**

#### 1. Terms of Reference:

The terms of reference for the auditors will include the following
