- 2. Last date for the receipt of completed quotations is up to 12:00 Hrs. of 12th July 2016.
- 3. The quotation must be valid for a period of 90 days from the date of opening.
- 4. Vendor should have at least 5 years proven experience in the relevant field.
- 5. The successful firm/contractor, within a period of 10 days, shall furnish a Bank Guarantee for 10% of the total cost of CMC, valid till the end of the contract period towards security for smooth performance of the CMC.
- 6. You are requested to submit Service Level Agreement.
- 7. The contract may be terminated by either party by giving one month's notice in writing.
- 8. Under this Comprehensive maintenance contract, the following services will be provide with material (tubes, valves, plumbing material) (excludes solar tank & manifolds without tubes)
- 9. Monthly preventive maintenance and checks.
- 10. Operating System level support with spare part.
- 11. Spare Parts required for Maintenance will be provided by supplier.
- 12. Any service apart from the agreed in the contract or any fresh work /Assignment will be charged for , at the charges agreed at that point of time.
- 13. Services shall be provided on all working day during 10:00 AM to 07:00 PM and on holiday in case of emergency.
- 14. On all working days to keep the machines / equipment in good working Order. The service consists, corrective maintenance and includes carrying Out the necessary repairs and fittings of parts.

15. The maintenance service With the following conditions includes:

- I. The Service Engineers shall attend the faults within 24 working hours from the time of complaint.
- II. The Service Engineers should maintain Log Registers for all calls Attended / pending issues / preventive maintenance records and details of spare replacement.
- III. No component(s) / spare(s) shall be removed without informing the Competent Authority.
- 16. Any leakages found in the system will be corrected at the time of regular visit.
- 17. De-scaling & cleaning units After six months.
- 18. Checking of heaters after three months.
- 19. Checking all joints on terrace & in ducts after three months if found any faults should be repairs.
- 20. Replacements of breakages of tubes as the brakeage occur.
- 21. Ball cock at inlet cold water tank should be check every month.
- 22. If rusting found in the stands or paint damaged same should be re paint.
- 23. All the systems should be running smooth.
- 24. If there any technical fault (ie. there will be shadow on the system) or any other manufacturing defect or not proper installation of system we are not responsible for performance of the system
- 25. **Penalty Clause**: Penalty shall be imposed for not meeting the SLA i.e. if not resolved the complaint within the resolution time, at the rate of Rs. 500/- for delay of every 24 hours and maximum up to 5% of the total contract value.

- b. Quarterly payment on completion of each quarter after satisfactory performance certification from concern division.
- c. TDS will be deducted as per government rules.
